AMA Spring Championship Supplemental Information

2. General Racing Rules

- 2.A. AMA Amateur Rules and Meet Supplemental Rules apply.
- 2.B. Stock Classes are defined by AMA.
- 2.C. All classes without Stock next to the Class Name are defined as Modified classes.
- 2.D. Age Effective Date January 1, 2011 for all classes except as described in 4.B.
- 2.E. This event is a non rain out event.
- 2.F. All areas of event are considered hot pit areas.
- 2.G. This event does not offer rider medical insurance. If you don't carry personal insurance on yourself, you are encouraged not to race
- 2.H. Rules and Information listed within this document may be revised at any time without notice.

3. Number Plates/Competition Number

- 3.A. All motorcycles must have contrasting number plates. IE: White number plate backgrounds with Black numbers, Black backgrounds with White numbers, or Yellow backgrounds with Black numbers. No other combinations will be accepted. All numbers must be bold and solid. No outlined numbers.
- 3.B. Rider may choose personal competition numbers.
- 3.C. Only promoter/referee may change competition number.
- 3.D. Competition number must be displayed on three sides of bike.
- 3.E. No duplicate race numbers are allowed within the same class. In the event there are, the rider keeping their original number will be based on who is registered first.

4. Age Effective Date/Policy

- 4.A. Age effective date for all classes is January 1, 2011 except in item 4.B.
- 4.B. Age effective date for all VET classes, Women's Am 99-250, and Collegeboy 17-24 is March 8, 2011.
- 4.C. Proof of age, original birth certificate or valid drivers license must be available upon request for event clerk or referee (failure to comply will result in immediate disqualification).

5. Minor Release Requirement

- 5.A. All minor riders must have a parent present or guardian/authorized adult with notarized statement.
- 5.B. If parent or legal guardian is not attending, then a notarized statement must be presented by authorized adult that is accompanying minor.
- 5.C. The adult in charge must remain present while minor is on the premises.
- 5.D. Adult with minor must be prepared to show proof of identity and guardianship.
- 5.E. When a notarized statement is necessary, bring two copies (one for event clerk and one for guardian/authorized adult).5.F. Notarized statement must be presented at the time of
- 5.F. Notarized statement must be presented at the time of registration at scoring tower.

6. Rider

- 6.A. Rider is not allowed to cut track during practice or race and not to double back to retry certain area(s) of track during practice.
- 6.B. Rider must enter and exit track at designated areas only.
- 6.C. It is mandatory to attend riders meeting as per schedule. Riders meeting is scheduled for Monday, March 7th at 6:00pm.
- 6.D. Riders meeting is also mandatory for mechanics.
- 6.E. Rider or designated guardian/parent/authorized adult is responsible for the actions of those in their pit area.
- $\ensuremath{\text{6.F.}}$ Rider is expected to adhere to AMA rules of conduct at event.
- 6.G. Women's Am 12+ is for Novice and Intermediate riders only.
- 6.H. Mechanics and Riders are responsible to adhere to "Starting Gates" procedures and policies (See section #13).
- 6.I. It is the rider's responsibility to listen (88.3 FM or PA) to announcements for updates throughout the meet.
- 6.J. Riders must be wearing wristband to finalize registration.

- 6.K. Riders may ride a stock motorcycle in the modified classes. Stock or modified 85cc riders may enter the Supermini class if rider age is legal for the class.
- 6.L. Rider must enter the class with the highest classification ever raced with any organization, event, meet or series.
- 6.M. Dead-Engine Policy: Must walk bikes from Pit Area to Staging and exiting Staging Area to Pits.

7. Registration

- 7.A. Registration has three options: 1. Online, US Mail, or Track.
 7.B. Online SignUp (Registration) can be found from the home page at www.FreestoneMX.com.
- 7.C. US Mail registration can be done by downloading the registration form from www.FreestoneMX.com. Simply fill out the form and mail it to:

- 7.D. Track registration opens on Monday of the event week at the Pro Tower. Note: All riders must check in.
- 7.E. Check the Schedule Info page for further registration information and links.

8. Pre-Entry Verification

- 8.A. All pre-entries will be posted at www.FreestoneMX.com after online entry deadline.
- 8.B. To insure you are pre-entered, go to the

www.FreestoneMX.com and under the "Results" button look to verify your full name, your correct class, competition number, brand of bike and hometown.

- 8.C. If you do not find yourself online or you find a mistake in the information posted, please contact Karen Miller at Karen@freesstonemx.com.
- 8.D. A \$5 fee will be charged for any refunds of pre-entries.
- 8.E. A \$10 fee will be charged for those requesting class changes

9. Transponder

- 9.A. Transponder scoring provided by eScore.
- 9.B. Rider must first pick up transponder before going to scoring tower to finalize registration to practice and race.
- 9.C. Transponder fee is \$40 rental plus a \$100 refundable deposit and is mandatory to compete during event.
- 9.D. Only one transponder per rider is needed no matter how many classes rider is entered.
- 9.E. Rider/Mechanic must know transponder serial number to retrieve lap times from eScore at event. eScore will provide transponder series number when picked-up at event.
- 9.F. Transponder is not available for purchase.
- $9.G.\ Transponder\ must\ be\ returned\ after\ racing\ is\ complete\ for\ the\ weekend.$
- 9.H. Additional questions can be answered at www.eScoreMX.com or email drew@escoremx.com.9.I. Transaction is done only at track. No pre-pay is available.

10. Timed Practice Qualifying/Gate Pick (1st Moto)

- 10.A. No qualifiers are required prior to attending event.
- 10.B. Rider must have practice wristband and transponder to enter track.
- 10.C. Lap time from your designated practice will be used for gate pick in first moto.
- 10.D. Fastest lap time will receive first gate pick in 1st Moto.
- 10.E. If a rider misses their designated practice group, rider will be given last gate pick in 1st Moto.
- 10.F. If class has more than one division, then lap times will be divided into required field. (IE: If there are three divisions, then Div 1 will have 1st best lap time from timed practice with first gate pick, Div 2 will have 2nd best lap timed rider as 1st gate pick, Div 3 will have 3rd best lap timed rider as 1st gate pick, etc.).
- 10.G. It will be the duty of the rider to insure staging official has checked transponder before entering starting gates.

11. Practice Order

11.A. Official practice order will be finalized and posted on Monday, March 7th by 6:00pm.
11.B. Practice order will be posted at Pro scoring tower.

12. Mechanics

12.A. Mechanics are required to attend Riders Meeting.

12.B. Only one mechanic per rider inside staging, starting gate or mechanics area.

12.C. Mechanics area is defined by promoter/referee.

12.D. Mechanics and Riders are responsible to adhere to Starting Gate procedures and policies.

12.E. Dead-Engine Policy: Must walk bikes from Pit Area to Staging and exiting Staging Area to Pits.

13. Starting Gates

13.A. Freestone County Raceway is an AMA Pro National track, thus the starting area is dirt start.

13.B. No dirt work is allowed past starting gate.

13.C. Only dirt work with hands or feet is permitted. No tools of any type allowed in staging or starting gates.

13.D. If a hazard is identified in front of gate other than dirt or rocks, please advise official to render judgment.

13.E. Only officials or track workers are allowed in front of gates.

13.F. Starting blocks are allowed for intended purpose only.

14. Impound Area

14.A. Top 10 from each class from each moto may be held inside impound area for up 10 minutes.

14.B. Only rider, bike and mechanic are allowed in impound area.

15. Protest

15.A. Any "VISUAL", "TECHINCAL", or "ADMINISTRATIVE" protest must be submitted on protest form.

15.B. Protest form can only be acquired from registration clerk in scoring tower.

15.C. Protest must be filed at scoring tower.

15.D. Decisions will be rendered in a timely manner.

15.E. All protest filed require a \$50 non-fundable fee per item.

15.F. All protest regarding scoring or administration must be filed within 30 minutes from the posted results time stamp.

15.G. Riders may compete under protest if no decisions has been rendered but still may be disqualified upon final decision.

15.H. If a bike should be protested, the rider has the right to have their bike impounded and held until the final moto of the day has been completed. Bike will be torn down at this time to determine if its legal or not.

15.I. The official may at anytime, upon visual inspection, declare a bike illegal for the class entered.

15.J. Reference AMA Rule Book Appendix 6.8 for complete information and fees.

16. Pro & Expert Payouts

16.A. Payouts are for overall results.

16.B. This is event is a Pro/Am event.

16.C. Pro/Am points are awarded for Pro Sport classes only at this event

16.D. 250 A, 250 Pro Sport, 450 A, 450 Pro Sport (1st-10th)

\$500, \$300, \$200, \$150, \$125, \$100, \$85, \$75, \$65, \$50

16.E. 25+ A, 35+ A, Womens Pro (1st-10th)

\$250, \$150, \$110, \$90, \$80, \$70, \$60, \$50, \$40, \$30

16.F. If field is less than 20 entries per class, then 50% of field will be paid out.

17. Factory Contingency

17.A. Riders competing for factory contingency must fill out event registration form with correct brand of motorcycle in order to receive such OEM payout.

17.B. Promoter will visually verify rider with bike brand.

17.C. Rider is responsible to register with manufacturer for factory contingency when applicable.

17.D. Factory contingency is supported by Cobra, Honda, Kawasaki, KTM and Suzuki.

18. Awards Ceremony

18.A. Awards ceremony is under the pavilion behind the scoring

18.B. Top 10 from each amateur class will be awarded

18.C. Top 3 Expert and Pro classes will be awarded.

18.C. Everyone is invited so bring your cheering section.

19. Pit Vehicle Permit/Policy

19.A. Pulling race bike with pit vehicle is NOT permitted.

19.B. Permitted Vehicles include: Golf Carts; Side-by-Sides,

Mopeds and Bicycles and may be used by permit only.

19.C. Pit Vehicle Permit is \$10 per vehicles (omit bicycles). Pit Vehicle Permit must be purchased at Pro Tower. Permit is for the week

19.D. Valid driver license and AMA card will be required at time of permit purchase.

19.E. Helmet is required for riders on Mopeds.

19.F. Maximum speed is 10 MPH.

19.G. All Pit Vehicles must not exceed passenger limits.

19.H. Drivers of Pit Vehicle must present Valid Drivers License (DL) to operate vehicle.

19.I. Pit Vehicle must have operation lighting or must be parked

19.J. No Pit Bike or ATV allowed.

19.K. Pit vehicle operating hours are from 6am until 10pm.

19.L. Pit Vehicle Permit is a privilege and may be revoked if policy is not adhered to.

21. Bike Wash

21.A. Bike washing is allowed in Pit Area however water cannot overrun into other pit areas or promoter may request that the designated bike wash be used.

21.B. Bike Wash is open to all and is located on the outside of the Pro pit fence on the north end. You must bring your own power washer and hose.

21.C. If the race day is designated as a "Rain Day", all bike washing MUST only be conducted at the designated bike wash.

22. Racer RV/Camping Permit/Policy

22.A. There are NO RV hook-ups.

22.B. There is no early parking or camping before Monday, March 7th, 2011 at 6:00am.

22.C. No over night parking is allowed outside of gates on County Road 995.

22.D. You may not save spots for friends. If you want to camp with friends, please meet them off-site and arrive together.

22.E. No Black/Grey Water dumping. Be kind to your neighbors.

22.F. Black and Grey water service is available.
